RE: Cecil County Transportation Priorities

Dear Secretary Porcari:

The Board of County Commissioners of Cecil County is pleased to have this opportunity to present the County's transportation priorities to your department. The Board is cognizant of the fact that the BRAC consolidation of defense jobs at the Aberdeen Proving Ground will affect Cecil County's transportation infrastructure. Accordingly, many of the items listed below are BRAC related. Please be advised that our priorities, in order of magnitude, are as follows:

1. Relocate the Tollbooths on I-95.
2. Placement of a new interchange on I-95 between MD Route 222 and MD Route 272.
3. Extend MARC commuter rail service to Elkton from its terminus in Perryville.
4. Extend SEPTA commuter rail service to Elkton from its terminus in Newark, DE.
5. Widen MD Route 222 to five lanes between U.S. Route 40 and MD Route 275 and improve the intersection at MD 222 and U.S. Route 40.
6. Improve the MD Route 213/U.S. Route 40 intersection.
7. Widen MD Route 272 to four lanes between U.S. Route 40 and I-95.
8. Develop access management plans for U.S. Route 40 and MD Route 222.

The Board of County Commissioners and our staff are available to discuss these items in greater detail and specificity if you so desire.


