- The addition of \$8,865,000 for the US 13 bridge over the Pocomoke River

This funding will allow the State Highway Administration (SHA) to replace the northbound US 13 bridge deck and complete an overlay system on the US 13 southbound deck over the Pocomoke River to address structural deficiencies.
