Dear Mr. Murrill and Ms. Hynes-Cherin:

The Maryland Department of Transportation (MDOT) hereby modifies the FY 2013 Maryland STIP to reflect a highway project administrative modification to the FY 2013-2018 National Capital Region Transportation Planning Board (TPB) Transportation Improvement Program (TIP) which was approved by the TPB on June 27, 2013. The modification is needed to break out and add funding to a project that is being constructed by two separate state agencies. The Anacostia Riverwalk Trail project was awarded TIGER funding and is identified in the District of Columbia's section of the TIP (TIP ID#3508). MDOT will now be obligating a portion of the funding and will also be using state funding towards the project. The modification will add this information to the MDOT section of the TIP. Details are summarized below and included in the attached information.
