



Minority business certification is designed to ensure that all applicants meet the eligibility requirements for participation in a particular race and/or gender-based public contracting program. Certification for participation in such programs is typically granted to disadvantaged, minority- or women-owned businesses. The certification process may also be used to identify businesses that are small, local or underutilized for participation in race- and gender- neutral contracting programs. The benefits of and requirements for certification vary among programs. Typically, the eligibility criteria for race-conscious programs are more rigorous than those for race-neutral programs.

Firms considering certification should carefully review each program's requirements for minority status, ownership, control, personal net worth, business size standards and residency when considering which program(s) best suit their business needs.
