## Welcome, Announcements & Introductions

MDOT Deputy Secretary, R. Earl Lewis, Jr., welcomed all meeting participants.

## Public Comments

Lanny Hartman, an EV driver from Howard County has asked Delegate Clarence Lam to amend the bill on Stopping and Standing (HB0839) to ensure that electric vehicles (EVs) parked in EV spaces do not have to be connected. Mr. Hartman also informed the Council that Howard County Councilwomen, Jen Terrasa, has sponsored local legislation (Council Bill 7-2016), which would prevent “icing,” by giving the Howard County Police Department the authority to ticket non electric vehicles in designated EV parking spaces on both public and private property.

## Status Update

Meg Andrews provided the Council with an update on where we are in terms of the number of electric vehicles in Maryland (estimated at 4,407) as well as the existing charging infrastructure (estimated at 843 outlets). The presentation also included a summary of relevant 2016 legislative proposals and a summary of the monthly energy usage in (kWh) at the existing MTA EV charging sites.

## **Workgroup Updates**

### Communications

Ms. Sorensen indicated that the committee was working on a basic communications plan and coordinating updates to the [www.marylandev.org](http://www.marylandev.org) website. The committee has identified the following needs:

- Better engage in social media.
- Ensure that regular updates to the website do not fall behind due to changeover in student help.
- Ensure consistency across Maryland EV-related websites.
- Better identify target audience, which will require funding.

The MDOT website, where EVIC's webpage is housed, is being revised. As a result, the links may not be current.

Konrad Herling suggested that a workshop be held at the upcoming MML conference in June. He also volunteered to reach out to the Maryland Association of Counties (MACo) EVIC member.

### Update on DC Fast Charge Projects (Mike Jones)

Mr. Jones, who is replacing Chris Rice as the EVIC member for MEA, reported on the status of the Maryland Electric Vehicle Infrastructure Program (EVIP) grant program. The award covered 26 DC Fast Charge stations:

- 15 Royal Farm Stores of which 10 are now open. These include locations in Central Maryland and along Route 50 to Ocean City.
- 4 NRG stations are in process. These are in negotiations with new site hosts
- 2 ChargePoint stations, also in negotiations with new site hosts.
