Dear Mr. Murrill and Ms. Hynes-Cherin:

The Maryland Department of Transportation (MDOT) hereby amends the FY 2014 Maryland STIP to reflect projects being added to the 2014-2017 Baltimore Regional Transportation Board's (BRTB) Transportation Improvement Program (TIP) for I-795: Dolfield Boulevard Interchange (SHA), Countywide Bridge Maintenance (Carroll County), Citywide Guide Sign Replacement (Baltimore City), and update the federal funds for Greenmount Avenue Reconstruction: 43rd Street to 29th Street (Baltimore City). Attached please find supporting documentation including the notification letter documenting the May 12, 2014, BRTB Executive Committee's approval of the Administrative Modification. A brief description of the action is shown below:

- I-795: Dolfield Boulevard Interchange – adds this project to the STIP,
- Countywide Bridge Maintenance – adds this project to the STIP ,
- Citywide Guide Sign Replacement – adds this project to the STIP, and
- Greenmount Avenue Reconstruction: 43rd Street to 29th Street – adds HHPP finds: \$560,000 in Federal and \$140,000 Matching Funds to Project Engineering, and \$800,000 in Federal and \$200,000 Matching Funds to Construction.

These funds have been made available primarily due to an increase in federal aid Obligation Authority assumptions and funds de-obligated on inactive projects. These costs do not affect the portion of federal funding programmed for transit.

Enclosed is an amendment updating the 2014 – 2017 Baltimore Region Transportation Improvement Program as approved by the BRTB on July 22, 2014.

The Interagency Consultation Group has determined that this project is non-exempt, yet additional analysis is not required to augment the project's initial conformity determination according to the Conformity Rule as the amendment will not change the design concept and scope or the timeframes of the project completion indicated in the conforming long range plan. The amendment underwent a publicized 30-day public review from June 18, 2014 to July 17, 2014 with a public meeting on July 8, 2014 and July 9, 2014.

The federal NHPP and STP funds have been made available primarily due to an increase in federal aid Obligation Authority assumptions and funds de-obligated on inactive projects. The state funds have been made available from the state's Transportation Infrastructure Investment Act (TIIA).

WHEREAS, the Baltimore Regional Transportation Board is the designated Metropolitan Planning Organization for the Baltimore region, encompassing the Baltimore Urbanized Area, and includes official representatives of the cities of Annapolis and Baltimore, the counties of Anne Arundel, Baltimore, Carroll, Harford, and Howard, as well as representatives of the Maryland Department of Transportation, the Maryland Department of the Environment, the Maryland Department of Planning, and the Maryland Transit Administration; and

WHEREAS, the Baltimore Regional Transportation Board, as the Metropolitan Planning Organization for the Baltimore region, approved the 2014-2017 Transportation Improvement Program for the Baltimore region at its November 26, 2013 meeting, with federal approval on May 19, 2014; and

WHEREAS, federal regulations require that all transportation-related projects must be listed in the approved Transportation Improvement Program with accurate funding schedules in order to be eligible for federal funding; and

WHEREAS, the Transportation Improvement Program consists of projects included in, and in support of, the region's long-range transportation plan and ongoing short-range planning efforts; and

WHEREAS, the Maryland Department of Transportation on the behalf of the State Highway Administration has requested approval of an amendment to add funding for the engineering phase of I-795 at Dolfield Boulevard (see Attachment 1) to the 2014-2017 Transportation Improvement Program through the approved Transportation Improvement Program amendment process; and

WHEREAS, the Transportation Improvement Program, as amended, continues to display financial reasonableness and re-affirms the appropriate project selection criteria whereby all requirements for a Transportation Improvement Program in the Moving Ahead for Progress in the 21st Century Act are met; and

WHEREAS, the Interagency Consultation Group has determined that this project is non-exempt, yet additional analysis is not required to augment the project's initial conformity determination according to the Conformity Rule (40 CFR Parts 51 and 93). The amendment will not change the design concept and scope or the timeframes of the project completion indicated in the conforming long range plan; and

WHEREAS, the proposed Transportation Improvement Program amendment was publicized for a 30-day review from June 18, 2014 to July 17, 2014 with a public meeting on July 8, 2014 and July 9, 2014 to allow for comments. No comments were received on this project.

NOW, THEREFORE, BE IT RESOLVED that the Baltimore Regional Transportation Board, as the Metropolitan Planning Organization for the Baltimore region, approves the attached amendment to the 2014-2017 Transportation Improvement Program for the Baltimore region and finds it to conform to the applicable Maryland State Implementation Plan and requirements of the 1990 Clean Air Act Amendments.






The Maryland Department of Transportation (MDOT) on behalf of the State Highway Administration (SHA) is requesting the Baltimore Regional Transportation Board to take action in the form of either Amendment or Administrative Modification to the FY 2014-2017 Baltimore Region TIP for two projects in Anne Arundel County and two in Baltimore County. The projects in Anne Arundel County are: MD 175, from Rockenbach Road to Mapes Road and MD 198/MD 295 Partial Interchange Reconstruction (Phase 1), and in Baltimore County are: MD 140, Garrison View Road to CSX Bridge and I-795 at Dolfield Boulevard Interchange Project. A description of the project requests are:

- MD 175, from Rockenbach Road to Mapes Road – adding a total of \$2 million in Surface Transportation Program Funds for Preliminary Engineering split between FY 2015 and 2016,
- MD 198/MD 295 Partial Interchange Reconstruction (Phase 1) – adding a total of \$1.6 million in Transportation Infrastructure Investment Act (TIIA) of 2013 Funds for Preliminary Engineering split though FY 2014 to 2017,

- I-795 at Dolfield Boulevard Interchange Project – adding a total of \$4 million in Surface Transportation Program Funds for Preliminary Engineering split between FY 2015 and 2016,
- MD 198/MD 295 Partial Interchange Reconstruction (Phase 1) – adding a total of \$1.6 million in National Highway Performance Program Funds for Preliminary Engineering split though FY 2014 to 2017.

We are requesting to take an appropriate action (Amendment or Admin Modification) to the FY 2014-2017 Transportation Improvement Program (TIP) to add funds to the engineering phase of the following projects:

- (a) MD 175, from Rockenbach Road to Mapes Road, Anne Arundel County (TIP ID #61-1401-39)
- (b) MD 198/MD 295 Partial Interchange Reconstruction (Phase 1) (TIP ID #61-1403-41), Anne Arundel County
- (c) MD 140, Garrison View Road to CSX Railroad Bridge (Phase 2) (Regionally Significant), Baltimore County, and
- (d) I-795 at Dolfield Boulevard Interchange project (TIP ID #63-0803-46), Baltimore County

The purpose of these projects is to provide improved access to the planned growth and major employment centers such as the Base Realignment and Closure (BRAC) and associated projects at the Fort Meade area in Anne Arundel County, the Owings Mills Transit Oriented Development (TOD) and the MD 140 Business Corridor in Baltimore County. We are adding state and federal funds to start the design phase of these projects. The planning studies have been finished or waiting for the identification of funding for the design phase for these projects.

(a) MD 175, from Rockenbach Road to Mapes Road, Anne Arundel County

An addition of \$2 million will be added to the engineering phase under the Surface Transportation Program (STP) for the widening of MD 175, from Rockenbach Road to Mapes Road, project in Anne Arundel County in FY 2015 and 2016. Reconstruction of the MD 175 at Rockenbach Road intersection is almost complete, and the reconstruction of the MD 175 at Mapes Road intersection was advertised in January 2014. The latter is expected to be completed spring 2017. The design of the MD 175 mainline section between these two intersections is moving forward to design.

The purpose of this project is to improve safety and operations along MD 175 and ease growing congestion resulting from the BRAC expansion at Fort Meade.

(b) MD 198/MD 295 Partial Interchange Reconstruction (Phase 1), Anne Arundel County

An addition of \$1.6 million will be added to the engineering phase, which was funded under the state's Transportation Infrastructure Investment Act (TIIA) of 2013, for the reconstruction of MD 198 from Russet Green East to the MD 295 NB Ramp and the widening of the two ramps serving southbound MD 295. The widening of the ramps is needed to accommodate additional turn lanes from MD 198. This fund will be used from FY 2014 to FY 2018. This is a breakout project of MD 198, from MD 295 to MD 32 project planning study. The project planning study is almost complete. The estimated cost of engineering for Phase 1 is \$2 million and is currently funded. Because the engineering phase will go beyond the timeframe of the current TIP, only \$1.6 million will be shown in the current TIP.

The purpose of this project planning study is to address congestion along MD 198 caused by substantial growth as a result of the BRAC project. The design of Phase 1 will begin this summer.

(c) MD 140, Garrison View Road to CSXT Railroad Bridge (Phase 2), Baltimore County

An addition of \$1.7 million will be added to the engineering phase, which was funded under the state's TIIA for the widening of MD 140, from Garrison View Road to CSX Railroad Bridge (Phase 2), in FY 2015 and 2016. The total cost of the engineering phase is \$1.7 million, which is funded at this time.

(d) I-795 at Dolfield Boulevard Interchange project, Baltimore County

An addition of \$4.0 million will be added to the engineering phase under the National Highway Performance Program (NHPP) for the I-795 at Dolfield Boulevard interchange project in Baltimore County from 2014 to 2017. The total cost of the engineering phase is \$5 million, which is funded at this time. Because the engineering phase will go beyond the timeframe of the current TIP, only \$4 million will be shown in the current TIP.

The purpose of this project is to provide improved access to the planned growth and major employment corridor along Red Run Boulevard on the west side of I-795 and to address vehicular, pedestrian and bicycle accessibility at selected intersections in the study area. The proposed interchange would also provide safety and capacity improvements along I-795, while supporting existing and planned development in the area.

The federal NHPP and STP funds have been made available primarily due to an increase in federal aid Obligation Authority assumptions and funds de-obligated on inactive projects. The state funds have been made available from the state's Transportation Infrastructure Investment Act (TIIA).

The Transportation Improvement Program (TIP) continues to be fiscally constrained. The cost does not affect the portion of the federal funding, which was programmed for transit, or any allocations of state aid in lieu of federal aid to local jurisdictions. 

Description:

Reconstruction of Greenmount Avenue between 43rd and 29th street, including milling/repaving, lighting, landscaping, new sidewalks and traffic calming.

Amendment: Update title and add funding to the preliminary engineering and construction phases, using National Highway Performance Program funds.

Justification:

Continuation of the original Gateway project begun in 2006 as the Baltimore City Gateway that is in need of rehabilitation/reconstruction to halt the physical deterioration of the roadway that jeopardizes motorist safety.

The City of Baltimore reviews every project throughout the design and engineering process for complete streets and bicycle facilities compatibility. DOT has a complete streets policy whereby projects are evaluated to ensure they meet goals for the corridor and neighborhood. DOT also has a bicycle policy whereby projects are reviewed for compliance with the Bicycle Master Plan and to the extent possible will install appropriate bicycle facilities to create a multi-modal transportation system throughout the City.

Baltimore City Department of Transportation (BCDOT) is requesting amendments to FY2014 – 2017 TIP for the following three projects:

Edmondson Avenue Bridge over CSX and Gwynns Falls (12-1002-43) – The changes requested in this project are to include additional \$3,900,000 in local match in FY15.

York Road Reconstruction: 43rd Street to 29th Street (12-1408-12) – BCDOT is requesting additional federal and local funds for design and construction of this project. We are requesting \$560,000 in federal and \$140,000 in HUR funds for PE and design services in FY14 and additional \$800,000 in federal and \$200,000 in HUR for construction in FY16.


We also are requesting technical correction to change title of this project to “Greenmount Avenue Streetscape – 29th Street to 43rd Street” from “York Road Reconstruction: 43rd Street to 29th Street”.

Citywide Guide Sign Replacement (12-1220-19) – This project was part of 2012-15 TIP amendment. BCDOT is requesting reallocation of earlier requested \$5,000,000 funds to cover both PE/ Design services and construction of this project. We are requesting to move \$400,000 in federal and \$100,000 in HUR funds for PE and design services in FY 14 and \$3,600,000 in federal and \$900,000 in HUR for construction in FY16.

Revised TIP forms for all three projects are attached to this letter and Fiscal Constraints for all above mentioned projects are maintained. We will be utilizing City’s share of appropriated federal funds to cover for federal funding requested in these TIP forms.
