The Maryland Department of Transportation (MDOT) hereby modifies the Fiscal Year (FY) 2019-2022 Maryland Statewide Transportation Improvement Program (STIP) to reflect changes to two highway projects in the FY 2019-2024 National Capital Region Transportation Planning Board (TPB) Transportation Improvement Program (TIP).

In addition, this amendment reflects a change in the project name from "MD 97 Montgomery Hills Study" to "MD 97 Highway Reconstruction," as MDOT SHA now is funding design.

The requested administrative modification reflects the shifting of previously programmed State and local funds to the current TIP years. First, MDOT SHA requests shifting \$420,000 in state funds and \$159,000 in local funds for planning/design from previous TIP years to FY 2019. The updated total planning/design cost for FY 2019 is \$1,052,000, which consists of \$893,000 in State funding and \$159,000 in Local funding for planning/design. **PURPOSE OF MEMORANDUM**

To request the MDOT Office of Planning and Capital Programming notify the FHWA Maryland Division of these two administrative modifications.

**SUMMARY**

On August 21-22, 2019, Metropolitan Washington Council of Governments Department of Transportation Planning (MWCOCG DTP) staff approved the following two MDOT State Highway Administration (MDOT SHA)-requested administrative modifications to the FY 2019-2024 TPB TIP.

**ANALYSIS**

*MD 97 at Montgomery Hills Highway Reconstruction (TPB 5420)* – This modification reflects the addition of \$2,852,000 to FY 2019-2024 TPB TIP planning/design funding for TPB 5420. This modification, which shifts previously programmed funds and adds new funds in FY 2019-2024, ensures the FY 2019-2024 TPB TIP reflects MDOT SHA’s updated programmed project expenditures and project

schedule in FY 2019-2024. This project's total cost, including funding yet to be programmed, remains \$52 million. Per the October 29, 2014 memorandum of understanding executed by MDOT and the Federal Highway Administration, this action is eligible to be processed as an administrative modification as TPB 5420 is a \$10 million-plus project and this action constitutes an increase in total funding no greater than 20 percent of existing total project cost. The MDOT SHA anticipates completing planning proceeding with preliminary design in the Summer of 2019.

*MD 223 at Dower House Road Intersection Improvements (TPB 6660 MC #19-10 07/08/2019)* – This modification reflects the addition of \$191,000 to FY 2019-2024 TPB TIP right-of-way acquisition funding for TPB 6660 MC #19-10 07/08/2019. This modification ensures the FY 2019-2024 TPB TIP reflects MDOT SHA's updated programmed project expenditures. This project's total cost is increasing from \$4.9 million to \$5.1 million. Per the 2014 MOU, this action is eligible to be processed as an administrative modification as TPB 6660 MC #19-10 07/08/2019 costs \$3 million-\$10 million and this action constitutes an increase in total funding no greater than 30 percent of existing total project cost. The MDOT SHA anticipates advertising this project for construction in September 2019 and opening improvements to traffic in the Summer of 2021.

The attached Statewide TIP (STIP) reports document MDOT SHA's modifications with respect to funding for the above projects. These actions do not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The modified funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid.

In addition, the Maryland Transportation Trust Fund (TTF) remains fiscally constrained. The TTF supports State transportation system operation and maintenance, MDOT administration, debt service, and capital projects. Semiannually, MDOT updates revenues and expenditures using two national forecasting companies' latest economic estimates. The MDOT published funding details in the FY 2019-2024 Consolidated Transportation Program (<http://www.mdot.maryland.gov/newMDOT/Planning/CTP/Index.html>) and FY 2019-2022 Maryland STIP ([http://www.mdot.maryland.gov/newMDOT/Planning/STIP\\_TIP/STIPandTIP.html](http://www.mdot.maryland.gov/newMDOT/Planning/STIP_TIP/STIPandTIP.html)).
