The Maryland Department of Transportation (MDOT) hereby modifies the Fiscal Year (FY) 2017 Maryland Statewide Transportation Improvement Program (STIP) to reflect the following administrative modification to a transit project in the Baltimore Regional Transportation Board's (BRTB) 2017 – 2020 Baltimore Region Transportation Improvement Program (TIP). The TIP has been modified to update funding information for a project related to urban transit services operated by Harford County.

The BRTB Executive Committee approved the administrative modification to its TIP on April 6, 2017. The MDOT has assigned Control #17-36 for these modifications to the STIP.

Enclosed is one Administrative Modification to the *2017 – 2020 Baltimore Region Transportation Improvement Program (TIP)* as approved by the BRTB Executive Committee on April 6, 2017. The Maryland Transit Administration requested to update the Urban Transit Systems – Capital Assistance (40-1602-05) project to include previously unobligated FTA Section 5339 funds in FY 2017. Total funding in the TIP increases from \$2.913 million to \$3.248 million.

This minor change is within the framework for an Administrative Modification and does not impact conformity. MTA has affirmed that fiscal constraint for their program of projects remains intact.

Pursuant to the prescribed Transportation Improvement Program MOU signed in 2014, the BRTB Executive Committee approved this change to the *2017 – 2020 TIP*.

Description:

Capital assistance for the purchase of vehicles, equipment, and facilities for Harford County (Harford County Transportation Services).

Justification:

Urban Transit Capital will enable Harford County locally operated transportation systems to operate such that local needs for service can be met.

Administrative Modification: This administrative modification updates FTA Section 5339 funds in FY 2017 to include previously unobligated funds. These funds will be used to replace Harford Transit's bus wash system and to provide additional video camera coverage to their expanded fixed route fleet. Section 5339 funds increase in the amount of \$268,000 along with an increase of \$67,000 in matching funds. Total funding in the TIP increases from \$2.913 million to \$3.248 million.

- 3.A Improve Accessibility -- Increase transportation alternatives for all segments of the population.

SUBJECT: Administrative Modification to the Baltimore Region FY 2017-2020 TIP

The MTA is requesting an Administrative Modification to the Baltimore Region FY 2017-2020 Transportation Improvement Program (TIP). MTA has increased federal obligation for Section 5339 funding in the amount of \$268,000. Harford Transit will use the additional funding to replace the bus wash system which has reached the end of its useful life. The additional funding will also be utilized to provide additional video camera coverage to the expanded fixed route fleet. The proposed additional funding is not new money; the majority is previously unobligated FFY 2014 funds that would otherwise lapse at the end of FFY 2017. The proposed actions will not impact scheduling or funding availability for other projects in the current TIP, which continues to be fiscally constrained.
