I. Welcome & Roll Call

Jon Morrison, chair, opened the meeting and welcomed attendees. He explained how the meeting would commence based on the agenda and asked if anyone wanted to make any revisions to the agenda before moving forward. Liz Fitzsimmons was absent from the call and Lisa Hanson from the Department of Commerce stood in for her.

II. Agenda Review and Approval of Minutes

Jon Morrison asked committee members if all were in favor of the meeting minutes from October and minutes were approved.

III. MD Department of Commerce: The Economic Impact of Trails

Meg Young, introduced Lisa Hansen who is standing in place of Liz Fitzsimmons to give a presentation. In addition, before Lisa Hansen's presentation, Meg Young explained how MDOT is currently working on their statewide transportation trails strategic plan and understanding who the stakeholders are and building a stakeholder base.

Lisa Hansen's (Liz Fitzgerald's slides) Presentation on trails:

Lisa began the presentation by stating the Maryland Office of Tourism is a part of the Department of Commerce that works closely with the State Highway Administration. Lisa explained the basics of what tourism manages, their vision and mission statement. The office of Tourism uses measurable objectives such as Market Expansion, Leveraging Partnerships, Maximizing Opportunities to achieve one outcome of Transactional Outcome which results in individuals spending more money in Maryland. Lisa Hansen shared Maryland's Leading Five Differentiators and specifically noted Maryland's Trail System Second-To-None. The Maryland Office of Tourism is looking to celebrate the 200th anniversary of American Railroading in 2027 partnering with BNO for an event titled "Trails and Rails". Lisa Hansen went over some statistics regarding Competitive Marketplace Marketing Budget and how the budget is dispersed into the Maryland Tourism Development Board, 2.5 million goes to 25 state recognized marketing organizations. Tourism increased in the state of Maryland from 2018-2023.

IV. Legislative Outlook & Vote

Nigel Samaroo, began the conversation on Legislative outlook adding that Jon Morrison and Jon Korin would also be presenting with him. Nigel Samaroo opened the meeting by discussing the MBPAC Legislative Sub-committee members and made a call for that have a pedestrian focus in addition to individuals with disabilities. MDOT members recused themselves from voting on the list of bills that they would be presenting during this meeting. The committee voted to support all bills presented in a letter, with the exception of the ebike registration bill which MBPAC opposes. MBPAC voted to sign onto a formal letter, post that on the website, and use it for conversations with legislators.

V. Old Business, Engagement Opportunities, & Public Comment

Meg Young provided updates on various transportation initiatives. She reminded everyone about the MBPAC email address for committee inquiries and mentioned that recent topics of interest included the Together for Transportation Funding Coalition and the Train Commission, both focused on how transportation projects are funded in the state.

MDOT highlighted the Vulnerable Roadway User Assessment survey, which is a federal requirement and must be updated every five years. The survey is part of a project to improve the safety of state highways and local roadways. This current effort will also inform the MDOT PSAP Corridors.

Additionally, Meg talked about the PSAP (Pedestrian and Bicycle Safety Action Plan) open houses. These open houses are part of a data-informed effort to redesign the most dangerous corridors across the state. The initiative started with five corridors, and round two includes eight new corridors that have been announced.

Lastly, regarding MBPAC membership, the Governor's Appointment Office would handle appointments for open seats after the legislative session ends in April.

VI. Annual Report Review & Vote

Antoine Wright discussed the annual report that has been in the works since 2020. The report includes an executive summary, year-in-review, membership information, and individual meeting highlights. There's also an appendix for detailed reports. Antoine performed an accessibility check to meet all standards.

The draft has gone through multiple rounds of feedback, and MBPAC voted to accept the draft report, with minor grammatical edits still expected. A few last-minute changes, like the distinction between ad hoc and subcommittees, couldn't be made due to time constraints, though it remains an important topic for future discussions. Antoine thanked everyone for their contributions, especially the pedestrian subcommittee, and noted that this year's process was much faster than last year's.

VII. MBPAC Subcommittee Reports

Patti Stevens expressed gratitude to Thomas Mackay from the Rail Policy Group and Andrew Burnish for their help in supporting the mapping work for the Trails Committee, particularly in developing the Eastern Shore Trail map. Patti highlights the significance of the 1992 Greenways Trails Commission and Map Atlas, noting how many of the trails and projects being worked on today were identified in the 1992 atlas. She praises the atlas for its countyby-county listings and maps of trails and projects. Patti suggests doing an inventory of the projects from the atlas to track which have been implemented and which are still ongoing. This work will be used to support the Maryland Eastern Shore Trail network. Patti Stevens listed the list of upcoming meetings at the end of her presentation.

Pedestrian Subcommittee – Marian Vessels, chair

Meg Young presented in place of Marian Vessels, Meg Young briefly discussed the quarterly subcommittee meetings that had already occurred and upcoming. Additionally, Meg Young showed a member survey from December at the last subcommittee meeting that reflected where committee members were located, where they were representing and what they were interested in.

Trails Subcommittee – Meg Young

Meg Young presented on behalf of the trails subcommittee. Trails Subcommittee meets bimonthly to discuss the MDOT Strategic Trails Plan. Meetings were held in September, October and December. The trail project life cycle analysis was announced during the last meeting. The committee is currently working on releasing an existing conditions report that will be released on the website.

- (a) In this section, "vulnerable individual" means:
- (1) A pedestrian, including an individual who is lawfully:
 - (i) Actively working on a highway or a utility facility along a highway;
 - (ii) Providing emergency services on a highway; or
 - (iii) On a sidewalk or footpath;

(2) An individual who is lawfully riding or leading an animal on a highway, shoulder, crosswalk, or sidewalk; or

(3) An individual who is lawfully operating or riding any of the following on a highway, shoulder, crosswalk, or sidewalk:

- (i) A bicycle;
- (ii) A farm tractor or farm equipment;
- (iii) A play vehicle;
- (iv) A motor scooter;
- (v) A motorcycle;
- (vi) An animal–drawn vehicle;

(vii) An EPAMD; or (viii) A wheelchair.

Meg Young: re: Who falls under the VRU umbrella?

generally people outside of cars (which have steel cages and protective features). At the top, people with disabilities who need ADA accommodations, children, older adults, people walking, people biking, people connecting to transit. Crashes involving these populations are often overrepresented in severe crashes - simply, a person hit by a car loses the fight. If you get hit by someone going 20mph there's a 10% chance it will be severe, but by the time speeds get to 40mph there is a 90% chance that person will be severally injured or die.

Adkins, Sean: How would the e-bike registration laws apply to organizations who own and operate e-bikes (like a Parks and rec department)?

very good question. agencies are asked to note operational and fiscal impacts of bills so we should include that

Marycella Dumlao : I'm interested to know how these e-bike laws will affect the rental companies. I don't often see personal e-bikes (at least in the city, they are mostly lime rental e-bikes) The rental company vehicles are actually all already registered with the city, don't know if the bill would require a second registration

Meg Young: very good question. agencies are asked to note operational and fiscal impacts of bills so we should include that

Adkins, Sean: Thank you, I'm thinking about e-bikes oriented to staff use in addition to rentals and therapeutic programs. Thank you.

Patten, Robert: Does the current law provide an exception for children and youth.

Meg Young: kind of -- if i remember correctly, there are exceptions to allow riding on sidewalks based on the size of the wheel or "play vehicle" designation.

(2) Where allowed by local ordinance, a person may ride a bicycle, play vehicle, or unicycle on a sidewalk or sidewalk area.

Patti Stevens: Ebike rebates were part of the Colorado Transportation Climate Bill as a mitigation strategy

Patti Stevens: Who would decide who is responsible in a vru collision?
