The Maryland Department of Transportation (MDOT) hereby modifies the Fiscal Year (FY) 2019-2022 Maryland Statewide Transportation Improvement Program (STIP) to reflect funding changes for a Maryland Department of Transportation State Highway Administration (MDOT SHA) project that is contained in the FY 2020-2023 Baltimore Regional Transportation Board (BRTB) Transportation Improvement Program (TIP). The BRTB Executive Committee approved the modification to its TIP on July 10, 2020.

Description:

This project replaces bridge no. 0317400 on Putty Hill Avenue over I-695. The new bridge will maintain two 12' lanes and include 6' bicycle-compatible shoulders with 5'8" sidewalks on both sides of the bridge.

Justification:

The existing bridge, built in 1961, is rated in poor condition.


Administrative Modification: This administrative modification increases funding for the construction phase in fiscal years 2020 through 2022 to accommodate additional utility work required for the project. Funding in the TIP increases by a total of \$2.26 million (\$1.808 million federal NHPP/\$452,000 matching). Total funding in the TIP increases from \$10.728 million to \$12.988 million.

This administrative modification reflects an increase to federal funding for the I-695: Bridge Replacement on Putty Hill Avenue project (TIP ID #63-2002-13) in FY 2020, 2021 and 2022. The MDOT State Highway Administration (MDOT SHA) is requesting an administrative modification to the Baltimore Regional Transportation Board (BRTB) FY 2020-2023 Transportation Improvement Program (TIP) to increase funding for TIP# 63-2002-13, *I-695: Bridge Replacement on Putty Hill Ave*nue.

The current cost of the I-695: Bridge Replacement on Putty Hill Avenue project has increased by \$2.26 million. This increase in the construction cost is due to the complicated replacement of utilities which span the existing structure. The total cost of this project is now \$13.4 million. The utility replacement work is anticipated to begin in the Summer of 2020. Most of the design and right-of-way funding for this TIP project was included in the Areawide Bridge Replacement and Rehabilitation project (TIP #60-9310-13). This project will replace a poor rated bridge built in 1961.

The attached Statewide TIP (STIP) report documents MDOT SHA's funding flow modifications for this bridge replacement project. This action does not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The modified funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid. The TIP continues to be fiscally constrained. The cost does not affect the portion of the federal funding, which was programmed for transit, or any allocations of state aid in lieu of federal aid to local jurisdictions.

In addition, the Maryland Transportation Trust Fund (TTF) remains fiscally constrained. The TTF supports State transportation system operation and maintenance, MDOT administration, debt service, and capital projects. Semiannually, MDOT updates revenues and expenditures using two national forecasting companies' latest economic estimates. The MDOT published funding details in the FY 2020-2025
