Directions to DNR Headquarters (580 Taylor Ave, Annapolis, MD 21401):

Access DNR Headquarters (HQ) from Herbert M Sachs Drive. ID is required to enter the building.

If walking, biking, or rolling:

No designated bike routes provide direct access to DNR HQ. If planning to bike to DNR HQ, consider consulting the [Maryland Bicycle Level of Traffic Stress map](#) to find a fitting route. Bikes may be walked or ridden on sidewalks, and people biking should yield to pedestrians.

If taking transit:

Annapolis Transit operates a shuttle from Navy-Marine Corps Memorial Stadium to the Central Business District. The shuttle runs every 20 minutes and stops in front of DNR HQ. More information is available online [here](#).

If driving:

The vehicle parking lot is located across Herbert M Sachs Drive, directly across from the building's main entrance (indicated with the red box on the map below). From Taylor Avenue, the parking spaces are on your right and across the road from the DNR building's main entrance. From Rowe Boulevard, turn south onto Herbert M Sachs Drive.
