PURPOSE OF MEMORANDUM

To request the MDOT OPPPD, notify the Federal Highway Administration - Maryland Division of this amendment to add the following project to the FY 2025-2028 STIP.

ANALYSIS

Bridge No. WO0702 - Fleming Mill Road over Dividing Creek Bridge Replacement – This requested amendment reflects the addition of a new project and \$100,000 for preliminary engineering to the FY 2025-2028 STIP. Preliminary engineering for the project includes \$100,000 in Highway Infrastructure Program funding, which does not require a state match. The current timber bridge is rated in fair condition and has a posted load limit. This project replaces the timber bridge and will no longer have a load limit. Preliminary design is anticipated to begin in Spring 2026 and be completed in Winter 2027/2028.

The attached STIP report documents MDOT's requested amendment with respect to funding for the above project. This requested action will not impact scheduling or funding availability for other projects in the current STIP, which remains fiscally constrained. The amended funding does not affect the portion of federal funding programmed for transit or allocations of state aid to local jurisdictions in lieu of federal aid.

In addition, the Maryland Transportation Trust Fund (TTF) remains fiscally constrained. The TTF supports State transportation system operation and maintenance, MDOT administration, debt service, and capital projects. Semiannually, MDOT updates revenues and expenditures using two national forecasting companies' latest economic estimates. The MDOT published funding details in the FY 2026-2031 Consolidated Transportation Program and FY 2025-2028 Maryland STIP.
