Welcome and Announcements

- Announcement of NEVI Discretionary Grant Programs by US DOT, originally expected November 15, 2022, is now expected in January 2023.
- Baltimore City Public Schools was awarded an EPA Clean School Bus Program grant. The City will receive \$9.4M to purchase 25 electric school buses.

Public Comments

 Lanny Hartmann commented on the challenges EV drivers confront in finding reliable public chargers. He commented that unreliable charging is a barrier to EV growth and recommends accountability, reliability standards, and third party monitoring to address the issue.



• Joel Hurewitz commented that with passage of HB0157 in 2022, he believes State and local weight restrictions are in conflict. He hopes federal funding can help with installing conduit in residential developments.

EV Parking Signage – Status Update

Lili Liang, Division Chief, Traffic Engineering Design Division, MDOT SHA

- In response to SB0146 passed in 2022, MDOT SHA developed a new signage series consistent with the Manual on Uniform Traffic Control Devices (MUTCD).
- The new signage series will be distributed to agencies and contractors that work with signage and will be made available via the ZEEVIC distribution list.

Maryland NEVI Program Update

 - Once approved, will send Agreements out for signatures
 - Expect Agreements to all be signed by February 2023

 - EVSE Rebate Program is 94% committed for this fiscal year, which is the final year the program is legislatively mandated.
 - o Clean Fuels Incentive Program (CFIP) FY23 application period closes 11/22
 - Clean Fuels Technical Assistance (CFTA) Program
 - Application period was extended again through 12/31, received 2 applications.
 - Determining next steps.

PSC – Amanda Best

- Reported that SMECO filed a request with the Commission for approval of residential and multifamily EV pilot proposals. The Commission will make a final decision on the proposals after an additional filing is made by SMECO based on the discussion and recommendations made at the November 7, 2022, Administrative Meeting.
- Audience question about an HOA's experience with difficulty keeping cost of electricity to a minimum, and keeping charging affordable.

MDOT – Virginia Burke – consolidated report with DGS and DNR

 Map of Public Chargers installed, or planned to be installed, on State sites, as authorized by the PSC Pilot Program. Progress to date: 17 MDOT sites, 16 DGS sites, 6 DNR sites.

• To date, DGS has installed 82 charging ports for State fleet charging, and has 21 additional ports under construction.
